Unfortunately, this continues a trend that last year saw business relocation outside the state increase five times faster than the number of businesses which left in 2009, according to Spectrum Location Solutions.

The Sacramento Bee ran a headline on the story about the recent business departures, *State Officials on Defensive about Business Climate*.

They have a lot to be on the defensive about.

Many reports speak to California's poor business climate and residents leaving the Golden State for jobs elsewhere. For example, CEO Magazine ranks California 50th in places to do business. The independent Tax Foundation places the

state 48th in a list of favorable business tax environments. The Manhattan Institute issued a report recently that said more tax filers are moving out of the state than moving in.

It is time to turn on the engine of the economy: Small Business.

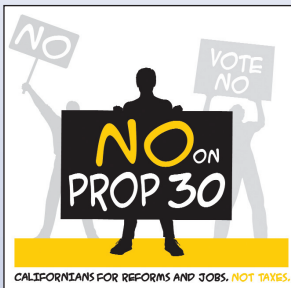

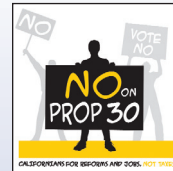
